### **Documentation for Students with Disabilities**

Appleby College Student Services is committed to accommodating the needs of students with disabilities in a way that responds to a student's unique circumstances. In accordance with the Ontario *Human Rights Code*, Appleby College will accommodate the needs of students with disabilities to allow them to access educational services equally, unless to do so would cause undue hardship. The school has Student Success Centre and Learning Strategist teachers who provide certain accommodations to assist students with exceptionalities to develop their individual potential. While Appleby College provides necessary accommodations to students with exceptionalities, it does not remove or modify program requirements based on this, including the School's co-curricular and boarding life program requirements.

Students requesting accommodation of a disability are responsible for providing appropriate documentation to the school during the admission process or immediately following a diagnosis, whichever happens first. The school may not be able to provide supports to students who do not inform the school of their exceptionalities and/or do not provide appropriate documentation or assessment information either at the time of admission or following admission to the school.

Documentation of any disability must come from a qualified practitioner who is certified in diagnosing and treating the student's particular disability. (A standard medical note from a family doctor does not meet the requirement for documentation.)

For a learning disability, a Psychological or Psycho-educational Assessment is required. The assessment should be no more than three to four years old. Current assessments provide the most accurate recommendations for the current level of learning. The assessment must be completed and signed by a registered psychologist or registered psychological associate. The assessment must include an assessment of cognitive functioning, an assessment of academic functioning, assessment and identification of the specific information processing deficits, assessment of socio-emotional functioning and a diagnostic statement confirming the learning disability. Test scores and subtest scores should be included in the report or as an addendum to the report. Recommendations for accommodation in the Appleby College environment should be listed. Families are required to keep reports updated and new assessments are asked to be completed and provided to the school every three to four years to maintain necessary accommodations and supports for students.

Documentation of medical or physical disabilities must be provided by the student's doctor and include a statement of diagnosis and nature of the disability or illness, a summary of symptoms including severity, duration and intensity, a description of expected progress or stability of the impact of the disability and how the disability might impact the student's ability to take part in the Appleby program.

For psychiatric disabilities, documentation must include the following: a statement of the nature of the disability, including the DSM-IV diagnosis, a summary of symptoms, including severity, duration and intensity, a description of expected progress or stability of the impact of the disability and how the disability might impact the student's ability to take part in the Appleby program.

In order for a student in need of temporary therapeutic support to receive reasonable accommodation, they must be under the care of a qualified medical practitioner and be receiving treatment to address their difficulties. Temporary supports may be provided, at the discretion of Appleby College, while the student is receiving treatment. Such supports will be reassessed at the end of every school year and may be discontinued depending on individual circumstances.

Documentation should explain the disability or illness, including presenting symptoms, their severity and the expected duration of the disability or illness. A statement of the impact of the disability or illness on the student's ability to take part in the Appleby program is also required.

All documentation should be sent directly to the Head of School and will be reviewed by the Learning Strategist teachers who have suitable training for interpretation of the assessment and/or reports. After a review of the documentation, the Learning Strategist teachers will prepare a Student Success Profile which outlines the accommodation and/or supports that the school is able to put in place. The Profile will provide teachers and other school personnel with strategies and supports to enable the student to work towards their full potential. All considerations for official academic accommodations provided by Appleby College are designed to align with current post-secondary standards to ensure students are provided with the best possible support and care.
